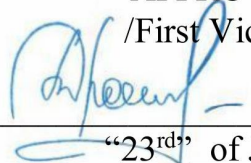

The purpose of the State Final Attestation B3.01 Preparation for the final state examination is to prepare graduates with a set of universal, general professional, and professional competencies. 3. determining the ability and readiness to perform practical activities provided for by the qualification and work activities within the framework of the job functions of professional standard 02.005 "Dentist" (Order of the Ministry of Labor and Social Protection No. 227n of May 10, 2016).

3. THE SPECIFICS OF THE STATE FINAL ATTESTATION B3.01 PREPARATION FOR THE FINAL STATE EXAMINATION IN THE SPECIALTY 31.05.03 DENTISTRY FOR FOREIGN STUDENTS (PEOPLE'S REPUBLIC OF CHINA ENGLISH-LANGUAGE NETWORK EDUCATIONAL PROGRAM), SPECIALIZATION 02 HEALTH CARE (IN THE FIELD OF DENTAL HEALTHCARE) FOR STUDENTS WITH DISABILITIES

3.1. Availability of appropriate conditions

For students with disabilities and special educational needs, state final attestation are conducted taking into account the characteristics of their mental and physical development, their individual abilities, and their health status. State final attestation for students with disabilities and special educational needs are held in the same classroom as students without disabilities, provided that this does not create difficulties for students with disabilities and other students during the state final attestation; the presence in the classroom of an assistant (assistants) who provides students with disabilities with the necessary technical assistance, taking into account their individual characteristics (occupying a work place, moving around, reading and completing assignments, communicating with the chair and members of the state examination commission); use of technical aids necessary for students with disabilities when taking state final attestation, taking into account their individual characteristics; ensuring unimpeded access for students with disabilities to classrooms, toilets, and other premises, as well as their stay in these premises (the presence of ramps, handrails, widened doorways, elevators; in the absence of elevators, the classroom must be located on the first floor; the presence of special chairs and other devices).

All local regulations of the organization regarding the conduct of the state final attestation shall be brought to the attention of students with disabilities in a form accessible to them. Upon written request of a student with a disability, the duration of the state examination for a student with a disability may be increased in relation to the established duration of the examination. The duration of the state attestation conducted in written form shall not exceed 90 minutes; the duration of the student's preparation for the state examination conducted in oral form shall not exceed 20 minutes; the duration of the student's presentation during the defense of the final qualification work shall not exceed 15 minutes. Depending on the individual characteristics of students with disabilities, the organization ensures that the following requirements are met when conducting the state final assessment tasks and other materials for taking the state attestation exam are printed in Braille or in the form of an electronic document accessible via a computer with specialized software for the blind, or read aloud by an assistant; written assignments are completed by students on paper in Braille or on a computer with specialized software for the blind, or dictated to an assistant; if necessary, students are provided with a set of writing utensils and paper for writing in Braille, a computer with specialized software for the blind. For the visually impaired: assignments and other materials for the state attestation exam are printed in large font; individual uniform lighting of at least 300 lux is provided; if necessary, students are provided with a magnifying device, and the use of magnifying devices owned by students is permitted. For deaf and hard of hearing students with severe speech impairments: sound amplification equipment for collective use is provided; if necessary, students are provided with sound amplification equipment for individual use or, at their request, state certification exams are conducted in written form. For persons with musculoskeletal disorders (severe motor function impairments of the upper limbs or absence of upper limbs): written assignments are completed by students on a computer with specialized software or dictated to an assistant; at their request, state certification tests are conducted orally.

Students with disabilities or special educational needs shall submit a written application no later than three months before the start of the state final attestation, indicating the need to create special conditions for them during the state attestation tests and specifying their individual characteristics. The application shall be accompanied by documents confirming the student's individual characteristics (if such documents are not available at the institution). In the application, the student shall indicate the need (or lack thereof) for an assistant to be present during the state assessment test, as well as the need (or lack thereof) to extend the duration of the state assessment test beyond the established duration (for each state assessment test).

3.2. Informing students with disabilities in a form accessible to them of all local regulations of the FSBEI HE PSMU of the Ministry of Health of Russia.

All local regulations of the FSBEI HE PSMU of the Ministry of Health of Russia on the implementation of the discipline (module) are communicated to students with disabilities in a form accessible to them.

4. STAFFING FOR PREPARATION FOR THE STATE FINAL ATTESTATION
